AIT and Fluxlink India Pvt. Ltd. agree to share each other's resources and leverage expertise for training, consultancy and R&D activities through this MoU on this date Day of September 2021.

ARTICLE 1: AREAS OF COLLABORATION

It is mutually agreed that upon the mutual consent of the institutions, collaboration shall be carried out to the extent feasible through such activities as listed below.

1. To impart training, internship, workshops to the students and staff of the Institute by company.

2. Company to provide regular active inputs in the training of the students of the Institute.

3. The Institute and the Company shall explore the possibilities of mutual support in their learning, hiring, training, internships and research requirements based on mutual convenience.

4. Supporting the faculty and students in allowing to use the facilities atFluxlink India Pvt. Ltd and AIT for getting practical experience in areasIndustrial automation and electrical machinery's.

5. ¬ Fluxlink India Pvt. Ltd will be utilizing the technical expertise, the labs and human resources of IT for its R&D activities, consultancy for development, testing and verification support for projects which will be done in collaboration with AIT.

6. Supporting student projects in the UG programs.

7. Permission to use materials related to work done in order to jointly publish papers.

8. When Fluxlink India Pvt. Ltd offers any consultancy or developmental projects to AIT, UG and PG students may be involved and they may take up project work at Fluxlink India Pvt. Ltd or at AIT. ARTICLE 2: IMPLEMENTATION

If the force majeure conditions continue beyond six months, the parties shall jointly decide about the future course of action.
