That in pursuance of said desire and to give effect to the same intentions and in consideration of the premises and for other diverse good intentions, the authors does hereby declare and state that the amount already handed over to the trustees as an initial contribution to HAVE AND TO HOLD THE SAME upon trust and the trustees shall hold and stand possessed of the sum of Rs.5,000/- (Rupees Five Thousand only) and any donations or contributions received by them and all accretion thereto and thereof and the investments and securities for the time being and from time to time representing the same (the assets being hereinafter referred to as the TRUST FUND) upon the trust and subject to the powers, provisions and declaration hereinafter mentioned and declared of concerning the same.

1. The name of the Trust shall be "AIT ALUMNI ASSOCIATION TRUST" with the Registered office at AIT, Jyothinagara Chikmagalur, for the present. The Registered Office may be shifted to any other place/s as the Board of Trustees may decide from time to time.

2. The Trust hereby created shall be IRREVOCABLE

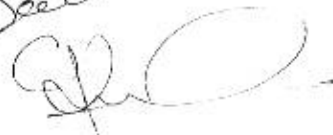

4. TRUSTEES AND THE BOARD OF TRUSTEES :-

- a. The control, management and Administration of the trust vests with the Board of trustees and executive Committee for day to day affairs, which shall have all the powers for the management of the trust fund fully and absolutely for the purpose of achieving the objects of the trust.
- b. The total number of trustees shall consist of following categories
- 1) The Director of AIT institution shall be a one of the ex-officio trustees
 - 2) The registrar of AIT Chikkamagalur shall be one of the ex-officio Trust
 - 3) The Principal of AIT Chikkamagalur shall be one of the Managing Trustee.
 - 4) Alumni of AIT consisting of Eight numbers shall hold the office of the trust for a period of three years and they shall retired and eligible for re selection for further period of three years.
 - 5) The members of Alumni any the authors of the trust shall select and appoint nominate 9 members of Alumni of AIT to the post of Trustee for a period of five years from the date of their appointment
- c) It is provided that in the event of any change effected to the name of the AIT Alumni Association or in the event of merger of the AIT, Chikkamagalur with another organization or any transformation to the very nature of the Association with, the new name or if a new association emerges for any reason, then, the board shall co-option such newly designated persons as Ex- Officio
- d) It is further provided that the term of the co-opted trustees shall be three years from the date of their co-option and after the lapse of which such Trustee/s shall automatically cease to be the Trustee/s. However, they are eligible for re co-option at the majority decision of the Life Trustees for further period of three Years.
- e) Eligibility to become co-opted trustee : He/She should be a former student of AIT Chikkamagalur and who is graduated in field of Engineering

f) Any vacancy that may arise for the reasons like resignation, death or insolvency of any of the trustees, the Life Trustees shall co-opt any other person to fill the vacancy so created. It is further provided that in the event of any vacancy created in the category of Life Trustees, the remaining trustees shall have the right to co-opt any other person for such and office, and the new trustee so co-opted shall rank with the other trustees detailed in category 4. (c) (c) supra.

5. MEETINGS :-

The board of trustees shall meet at least twice a year and shall review the accounts, the activates of the trust. Further, the board of trustees may frame such rules and regulations detailing the procedure for the meeting of the board of trustees. The board of trustees shall cause to maintain the Minutes of the proceedings of the meeting and such recorded minutes shall be approved in the ensuing meeting of the Board of Trustees.

EXECUTIVE COMMITTEE :-

The Trustees from amongst themselves, shall select/appoint or nominate one President, one Secretary, one Treasurer, 6 Directors and ex-officio trustees who shall have the power of representation and the day to day management of the affairs of the Trust. Their term of office shall be for period of Five years. However they are eligible for re election

POWERS OF THE EXECUTIVE COMMITTEE:

The body so constituted as stated hereinabove shall be collectively referred to as the 'Executive Committee'. The Executive Committee and the members thereof shall have the following powers, duties and responsibilities:

The President/Secretary shall represent the Trust before the Central/State Governments, Semi Governmental Bodies and before other Banks, Financial Institutions etc. The President/Secretary is also hereby specifically authorized to appear before the Deputy Commissioner, the Officials of Land Revenue Departments etc., and such other Departments, to correspond, sign and execute such papers, documents or instrument as are required in connection with the properties of the trust, either at the time of acquisition and later on and to appear, initiate, represent, defend before the Civil Courts,

High Courts etc., to institute, prosecute any legal matters in the appropriate forum from time to time, for and on behalf of the Trust. In the absence of President/Secretary, any other person specifically authorized by the Board of Trustees may carry on any/all the activities stated hereinabove and as authorized by the Board of Trustees.

The President and the Treasurer collectively shall keep or cause to maintain the proper Books of Account of the Trust regularly. The Trust shall prepare Annual Statement of accounts, which shall be closed on the 31st of March, each year, and the same shall be got audited by a Chartered Accountant.

The Bank Account or accounts shall be opened in the name of the Trust and shall be operated upon by the President/Secretary along with the Treasurer. They are hereby authorized to open, operate, maintain or close a Banking Account or accounts in the name of the said Trust. They can deposit money in Fixed Deposits in Banks or in Government, Limited Companies or invest amounts in National Savings Certificates, Government Bonds or Securities or in Postal Savings Deposits or Schemes or in Units of the Unit Trust of India or in any Central or State Government Securities, Bonds, Debentures, Loans etc., or Debentures of Government or Limited Companies, or in any other modes of investments as provided under the provisions of Section 13(1)(d) read with section 11(5) of the Income tax Act, 1961.

In all the Executive Committee meetings and the meetings of Board of Trustees, the decision of the majority shall prevail. However, the President/Chairman of the meeting, in case of a tie, shall have a casting vote.

6. POWER AND DUTIES OF THE BOARD OF TRUSTEES :

With a view to carrying out the objects of the trust hereinabove mentioned and to manage and administer the trust funds and properties and without prejudice to the generality of any powers hereby or by law conferred or implied or vested in the board of trustees, the board of trustees shall have the following powers.

- a) To receive any money or other assets in any share or form as gift or donation towards corpus or otherwise and to hold the same as Capital Fund and/ or apply it for furthering the objects of the Trust.
- b) To dispose of, alter or vary the investments from time to time and realize the investments subjects to sub clause (a) of above.

- c) To compromise, compound, abandon, submit to arbitration or otherwise institute any action, suits, proceedings, claims or other things, whatsoever, arising out of the administration of the trust fund, and to enter into, give, execute such agreements, leases and/or other things as may be seen expedient, without being liable or responsible for any loss occasioned by any act or things so done by them in good faith.
- d) To acquire or to dispose of through purchase or sale, mortgage, hire, lease or otherwise movable or immovable, tangible or intangible properties and rights and benefits and to manage the same. However, no property of the trust shall be sold without the unanimous or majority decision of the board of trustees.
- e) To receive, collect or realize or cause collection or realization of all income that accrue or become due on all or any investments and to issue receipts and discharges.
- f) To represent to trust in all courts (Original and Appellate) or before judicial or quasi judicial authorities and other authorities, departments or government, semi government or local authority.
- g) To sign and verify all pleadings, memoranda or appeals, petitions and application of all kinds and to engage lawyers and other professionals and to take such other necessary steps for safeguarding the interests of the trust.
- h) To borrow or raise any money that may be required by the trust upon such terms as may be deemed fit and to secure any money so borrowed by mortgage or creating charge on all or any part of the assets belonging to the trust.
- i) To open and maintain accounts with Schedule bank/s and authorize operations of such accounts Treasure along with President or Secretary jointly duly authorized by the board of trustees and to draw, accept, endorse, discount and/or negotiate negotiable instruments on behalf of the trust. The elected office bearers board of trustees, may however, adopt the required resolution to authorize any other trustee/s to operate the bank accounts from time to time.
- j) To pay out of the trust funds, salaries, wages, rent, building maintenance, repairs and other expenses relating to the trust, its administration and management of its activities or its other affairs.
- k) To appoint committees or sub-committees from amongst the members of the board and/or along with others or comprising persons other than the trustees and assign duties and to frame such rules of business in order to control and regulate the procedures of such committee or sub-committee.

- l) To undertake and carry on any work which may seem to the board capable of being conveniently carried on in connection with, or calculated, directly or indirectly to help the promotion of the objects of this trust.
- m) To decide all questions arising in the administration of trust and including all questions relating to the interpretation of these presents, the administration of any institution maintained by the trust or concerning anything or any matter related to or connected with or arising out of these presents of the operation thereof. The decision of the board in all or any of the matters aforesaid shall be final.
- n) The elected office bearers and six Directors among the board of trustees shall conduct the activities of the trust in accordance with the stipulations set out herein. The board of trustees may delegate all or any of the powers vested in them to such person/s for such period as they may deem fit and may at any time revoke, vary, alter, rescind such powers so delegated.
- o) The powers enumerated in these presents shall be exercisable by the board strictly in conformity with the terms and conditions laid down under the provisions of the Income tax Act, 1961, as amended from time to time so that the income of the trust will be exempt from Income tax and the donors will get deduction in respect of their donations under section 80 G of the Income tax Act, 1961, for each and every assessment year.
- p) To do all other acts, deeds and other things and matters, which may be deemed necessary for carrying out the objects of this trust or its administration.

7. FUNDS OF THE TRUST :

The funds of the trust shall be invested in the name of the trust in fixed deposits and schemes or the units in unit trust of India or as permitted by the Income Tax Act 1961 as amended from time to time.

8. ACCOUNTS :-

The board of trustees shall cause to maintain proper books of account in the usual course and as are required by various statutory acts. The books of account so maintained shall be got audited by a Chartered Accountant every year. The financial year shall be from 1st April to 31st March of every succeeding year. However, the first financial year shall be the date of Establishment of this trust and ending on 31st March 2023.
